Removal goods	<p>Italian Citizen returning:</p> <ul style="list-style-type: none"> • Consular declaration issued by the nearest Italian Consulate stating the length of the stay abroad (at least 12 months), names of family members and the returning date • Passport copy. • Italian fiscal code. • Original certificate of residence that has to be required as soon as back in Italy. • Autocertificazione (important document which implies the penal responsibility of the owner) in which customer declares: <ul style="list-style-type: none"> - His transfer of residence from abroad to Italy, the status of his family and the value of the goods. - The electrical appliances, such as TV, radio, Hi-Fi and video-recorder, should be listed with serial number, trademark and date of purchase. The appliances have to be "CE" or acquired before 1/1/1996 (proof of purchase may be required). <p>Foreign Citizen:</p> <ul style="list-style-type: none"> • Permesso di soggiorno (permission to stay in Italy, which is released by Questura). Necessary to get the visa permit (long procedure). • 2 originals of certificate of Residence issued by the Italian City Hall indicating the provenience. • Photocopy of the Passport 2 first pages. • Photocopy of the Italian Fiscal Code released by the Ministry of Finance. • Working declaration from the Italian company the customer will work for 	<p>As a general rule the Italian Customs authorities grant free entry to used household goods removals and used car.</p>	<p>Tobacco in any form, spirits in large quantities or firearms should not be included in the shipment.</p> <p>If shipping documents and consular certificate are available before the arrival of the goods, the shipment may be cleared through Customs in advance of owner's arrival.</p> <p>Import clearance usually takes 5 to 8 working days, depending on port of arrival/terminal.</p>

Foreign Diplomats and personnel coming to Italy to join an official International Organisation will obtain the "Diplomatic Franchise" through the Ministry of Foreign Affairs in Rome. This procedure takes from 4 to 6 weeks. Therefore, pre-movement advice is advisable in order to avoid delays.	Firearms should not be included in the removal.
Wedding trousseaux	<p>The applications should be accompanied by the list of objects comprising the trousseau, the wedding certificate and the certificate of residence in Italy of the married couple.</p> <p>Each present cannot exceed Euro 1000.</p>	<p>Customs office authorises import in franchise of trousseaux and wedding presents belonging to women of Italian or foreign nationality who as a result of their marriage with an Italian citizen, are electing domicile in Italy. Application should be addressed to the customs office, which performs the import operations.</p> <p>An authorisation for import in franchise is issued in each individual case, by the Directorate-General of Customs of the Ministry of Finance for Italian or foreign women who reside in Italy as a result of their marriage with a non-Italian citizen.</p> <p>Wedding trousseaux are not admitted duty-free into Italy. However, they can enter duty-free as removals if they are used and importation is connected with a transfer of residence.</p>	Motorcars are not considered as part of wedding trousseaux and therefore are not granted duty-free entry.

Works of art, antiques		It is advisable to obtain temporary admission from the Office of Fine Arts (Ufficio Esportazione Oggetti Antichi e Arte) for the importation of antiques (paintings, books, carpets, tapestries, etc.) included with the furniture of foreigners who take up residence in Italy, in order to avoid payment of export duties in the event of a subsequent transfer from Italy to another country. This temporary admission permit is valid for 5 years and can be renewed each time for another period of 5 years.	
Precious metal objects		Duty free entry is allowed on the same basis and under the same conditions as furniture and other articles.	No particular prescription for the importation of silverware within a household goods shipment.
Radios, VCR, Stereo, Camcorders, televisions, computer	Import licence called "Nulla-Osta per il Ministero delle Poste e Telecomunicazioni" specifying the make, model and serial number.		All owners of a television must pay an annual subscription. Not required for radios.

Dangerous goods, firearms	<ul style="list-style-type: none"> • Firearms and ammunitions must be listed in the inventory with indication of make, type and number. • A special permit for their importation must be obtained from the Police Office (Questura Centrale) and from Explosives Department Office. 		Firearms and ammunitions cannot be included in the shipment, but must be shipped in a separate crate.
Narcotics, drugs		Importation prohibited.
