Dogs and cats (from area free of rabies) directly: Japan, UK, Sweden, NZ and Iceland	Health and vaccination certificate approved by the Government. Photo (animal) 4 copies. Copy of owner's passport. Please telex the destination agent before you send the animal to Taiwan.	No quarantine.	Please note: You cannot import the animal before your agent obtains the import licence in Taiwan. Dogs and cats cannot be imported from Australia, Malaysia and Singapore.
Birds	Certificate of no Fowl Pest, no Newcastle disease, no Psitta Casis, approved by the Department of Agriculture of Local Government.	Quarantine of nomore than 7 days in Taiwan.
